T2S Release 2023.JUN

For information

- Release 2023.JUN
 - Successfully deployed on 10 June 2023.
 - Final scope: 11 CRs
 - 3 CRs enhancing the securities settlement/transactions (CR-0740, CR-0763 and CR-0779)
 - 3 CRs improving the handling of high volumes, in the context of the onboarding of Euroclear Finland (CR-0761, CR-0762 and CR-0781)
 - 1 CR providing more information to perform reconciliation (CR-0551)
 - 3 CRs improving the flexibility of the configuration of software (CR-0638, CR-0764 and CR-0769)
 - 1 CR raised in the context of CSD Regulation (CR-0787)

Release 2023.JUN (continued)

For information

- Impacts stemming from the DWH quality and Go/No-go decision to PROD
 - On 25 May 2023, the PMG agreed with the non-activated technical deployment of T2S DWH CR-0699 (*Decommissioning LTSL, scope and definition of queries and reports and access specifications to Data Warehouse functionalities*) in the R2023.JUN release
 - On 25 May 2023, the PMG recommended to T2S SL to descope T2S DWH CR-0733 (*Definition of a classification of transactions for CB T2S data*) and CR-0753 (*Export of T2S cash transactional data from the Data Warehouse to a Eurosystem's analytical platform*) from T2S R2023.JUN.
 - T2S SL approved the descope of both CRs on 30 May 2023.
- The new release planning of the DWH is under discussion
